Introduction

Fasmicro Partnership Scheme (FSP) is a partnership program developed by First Atlantic Semiconductors and Microelectronics Ltd as a way of assisting various businesses, companies, groups and individuals to achieve financial breakthrough in their business without hassle. In a keyframe: “we do the job, you earn!” – all that is required of you is to refer viable clients to us or clients you believe would be interested in our products and services, we follow them up until they yield, while you sleep,– “you then earn your cash!”. The partnership is a total open system for businesses, companies, groups and individuals wishing to partner with us and grow their businesses. We pay you when your lead executes.

What you should know:

Fasmicro has chains of products and services which are marketable to the general population of Nigeria and Africa, and you are on your way to representing us in your own state and locality – that is how you partner with us.

All products which you are authorized to market are listed in a document known as the Fasmicro Products Definition Sheet (PDS). The PDS guides you towards understanding our products and services and the costing attached to them. The PDS can also be viewed or downloaded from our website as it is constantly updated as more products follow. If there are clients seeking products and services which are not listed on the PDS, you can still refer such client and leave the rest to us – we follow up on the clients and when the lead executes, you still earn your commission.

When you join our FPS program, we open an account for you. All commissions are reflected on this account in our office – we send you weekly statement of your account via email or on your request.

There are two basic states of income in your account:

Amount Pending: When you refer a client/lead (PLR) and the client has not yet paid and the service pending execution, we fund your account with the commission value which you cannot withdraw until the client pays and project executes.

Amount Payable: When we have confirmed payment from the client through our bank account and we proceed to complete the project (PLE), we move the money from the pending vault into your withdrawable vault and alert you! – now you can order your payout instantly!

FSP - Earnings are paid by commission per client – Per Lead Executed (PLE), not Per Lead Referred (PLR)!. What this means is that if you refer a client to us, while the project has not been awarded and completed, we refer to your effort as – an PLR and it is your duty to make sure the client understands our product and services as listed in the PDS. When we get an PLR from you, we take it up and follow up on the client until the client pays and we finish the job and deliver – we refer to this stage as PLE and this is when you can request for a payout. Commission payouts are usually ordered between days – 20th to 31st of the ending months so that your cheque can reach you by the first week of the next month. Our company can also be authorized to pay into your account directly. This method is faster and takes three working day from the date you sent us a payment order. FPS commission ranges from 5% to 20% and are paid according to partnership level.

How to Become a member

Membership is 100% free and there is no limitation or eligibility issues attached to membership and partnership – this means that anyone can choose to become our partner in any part of the world. There are two basic ways of joining our FPS program; (a). Direct with our company/staff, (b). Invitation from a LEVEL-2 Partner who wants to move on to LEVEL-3. Whichever method of invitation you fall into, note that no cost is attached for membership.

When you sign up with our FPS, you are automatically added to the LEVEL-1 Membership and your commission would be set to 5% on all PLEs. You can migrate from one level to another higher level with instant appreciable rise in your commission level. Below are the details of the four levels of

LEVEL 1: **Affiliate**

This is the kick-off level on the FPS program. We pay you [5%] on all PLE and you can have your money in Cheque or have it deposited into your bank account on request. Your Level-1 FPS account becomes active when you refer your first job.

Features : You are not authorized to alter the cost of products and services listed in our PDS. In the case of negotiable services or products, any inflation of cost or maintenance cost shall be added up in the total cost of services and commission shall be paid to you based on the total cost and the inflation added-up.

Moving to LEVEL-2 : To migrate to LEVEL-2 and start earning 10% commission you will have to refer at least 5 jobs to us on your own FPS account. Once up to 5 jobs executes, we will automatically upgrade you to LEVEL-2 and 10% commission payout.

LEVEL 2: Affiliate

This is the second level on the FPS program. We pay you [10%] on all PLE and you can have your money in Cheque or have it deposited into your bank account on request.

Features : You are not authorized to alter the cost of products and services listed in our PDS. In the case of negotiable services or products, any inflation of cost or maintenance cost shall be added up in the total cost of services and commission shall be paid to you based on the total cost and the inflation added-up.

Moving to LEVEL-3: To migrate to LEVEL-3 and start earning 15% commission you will have to refer at least 5 other partners to us on your own FPS account. Once up to 5 partners signs up with at least one job, we will automatically upgrade you to LEVEL-3 and 15% commission payout.

LEVEL 3: Partner

This is the third level on the FPS program. We pay you [15%] on all PLE and you can have your money in Cheque or have it deposited into your bank account on request.

Features : You are authorized to alter the cost of products and services listed in our PDS. In the case of negotiable services or products, any alteration of cost or maintainance cost shall be added up in your commission and shall be paid to you in addition to your commission. You shall be given a fasmicro email, a business card and I.D card. You are entitle to two business training every year.

Moving to LEVEL-4 : To migrate to LEVEL-4 and start earning 20% commission you will have to encourage your LEVEL-3 downline (partners you refer) to get to Level-3, once at least 2 – PARTNERS under you gets to LEVEL-3, we will automatically upgrade you to LEVEL-2 and 20% commission payout.

LEVEL 4: Partner

This is the final level on the FPS program. We pay you [20%] on all PLE and you can have your money in Cheque or have it deposited into your bank account on request.

Features : You are fully authorized to alter the cost of products and services listed in our PDS. In the case of negotiable services or products, any added cost or maintainance cost shall be added up to your commission and shall be paid to you in addition to your commission.

Getting Certified: We encourage you to get a certificate of partnership with us. To get qualified for a partnership certificate, the remaining three (2) of your level-2 downline must get to level-3, then we will issue you a certificate of partnership and a web site e-store will be developed for your company free of charge.
